

They exemplify the critical impact that Boys & Girls Clubs have on the lives of young people.

This year the Club chose Camilo Fredes as our 2015 Youth of the Year. Camilo lives in Bayville with his parents and two siblings and is a senior at Locust Valley High School. Camilo is on the Varsity Tennis and Track teams. He has been a Club member for the past seven years. This past twelve months he has performed more than 80 hours of community service. He has maintained an A average as an IB diploma candidate, taking on the most difficult curriculum that Locust Valley High School has to offer. Camilo's teachers have praised him for his work ethic and his acute reasoning skills.

As a natural leader, Camilo has had a positive impact on his peers. 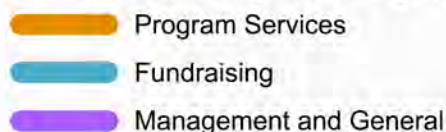
## 2014 Funding Sources
