THE EXPLORER CLUB MEMBERSHIP FOR GRADES K - 2 INCLUDES INSTRUCTIONAL SPORTS AT NO EXTRA COST WITH SOCCER IN THE FALL, BASKETBALL IN THE WINTER AND BASEBALL/SOFTBALL IN THE SPRING. ATHLETIC PROGRAMS ARE SUPERVISED BY TRAINED INSTRUCTORS TO HELP KIDS IMPROVE THEIR PHYSICAL FITNESS AND CONFIDENCE, INTRODUCING KIDS TO COMPETITION IN A RESPECTFUL AND NURTURING ENVIRONMENT. THE CLUB'S SUMMER CAMP INCLUDES A BASKETBALL AND GYMNASTICS CAMP OPTION. IN 2017, THE ATHLETICS DEPARTMENT SERVED 850 CHILDREN AND TEENS.
