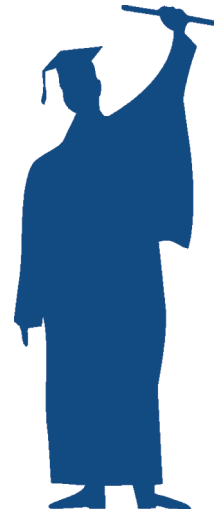

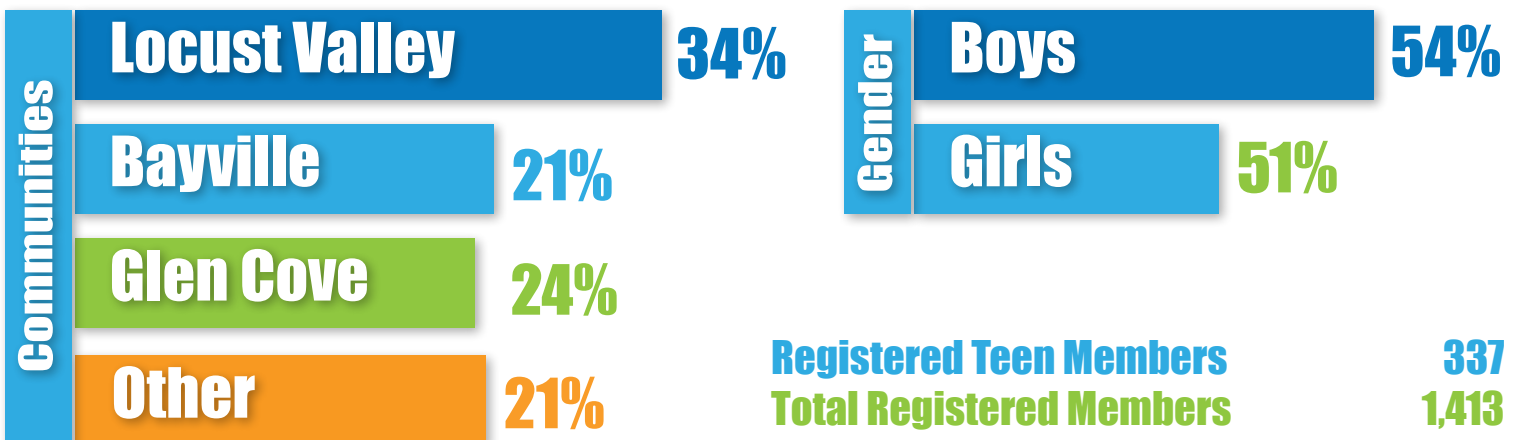

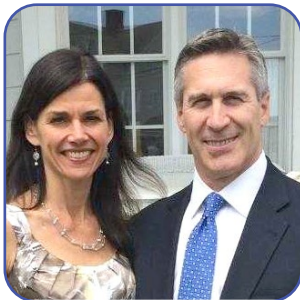

Eric and Keri Carlstrom have been inducted into the Grenville Baker Boys & Girls Club Hall of Fame in recognition of their decades of dedication to the Club and local youth. Honored at the 73rd Annual Gala, Moondance by the Bay, they are celebrated for their leadership and unwavering commitment—Eric, an Executive Managing Director at Aon, has spent over 25 years advancing the Club's mission through Board service, committee leadership, and co-chairing the 2000 Capital Campaign, while Keri, a former educator and active community volunteer, has generously given her time to numerous Club initiatives and now serves as President of the Locust Valley Library Board of Trustees. Together, they embody the spirit of Grenville Baker through their compassion, service, and commitment to helping every child thrive.

Veronica and Robert Chasanoff



Since moving from Manhattan to Locust Valley in 2000, Robert and Veronica Chasanoff have been dedicated supporters of Grenville Baker Boys & Girls Club and their community. Robert joined the Board of Directors in 2002, helping oversee the construction of the R. Brinkley Smithers Gymnasium, and later served as Board President before he and Veronica were honored at the Annual Gala. Beyond the Club, Robert has remained active through his Thoroughbred breeding operation and longtime service on Northwell Health's Board of Trustees, while together they have championed healthcare and education through initiatives like the Chasanoff Scholarship at Hofstra University's Zucker School of Medicine and support for pediatric transplant programs. Veronica, a former American Ballet Theatre dancer personally hired by Mikhail Baryshnikov, brings a distinguished arts legacy, and together they are proud parents of Brian and Jamie—especially valuing Brian's continued volunteer work with the Club.

Edith Hay Wyckoff *



Edith Hay Wyckoff—pioneering journalist, author, and community leader—was posthumously inducted into the Grenville Baker Boys & Girls Club Hall of Fame for her lasting impact on Locust Valley. A 1935 Great Neck High School graduate, she founded the Locust Valley Leader in 1943 and led it for nearly 60 years as a trusted local voice. In 1946, after seeing boys playing near railroad tracks, she welcomed them into her office—an act that led to the creation of the Bluejacket Club, the Locust Valley Athletic Club, and ultimately the Grenville Baker Boys Club in 1950, alongside community partners. A passionate advocate, she also opposed the proposed Cross Sound Bridge, and her compassion and leadership continue to inspire generations of North Shore youth.

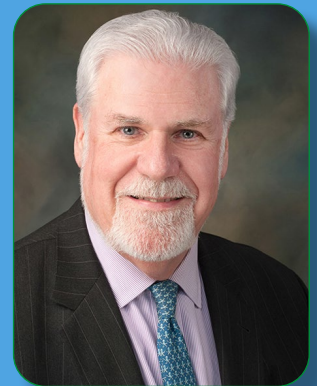
The Robert Gardner Award

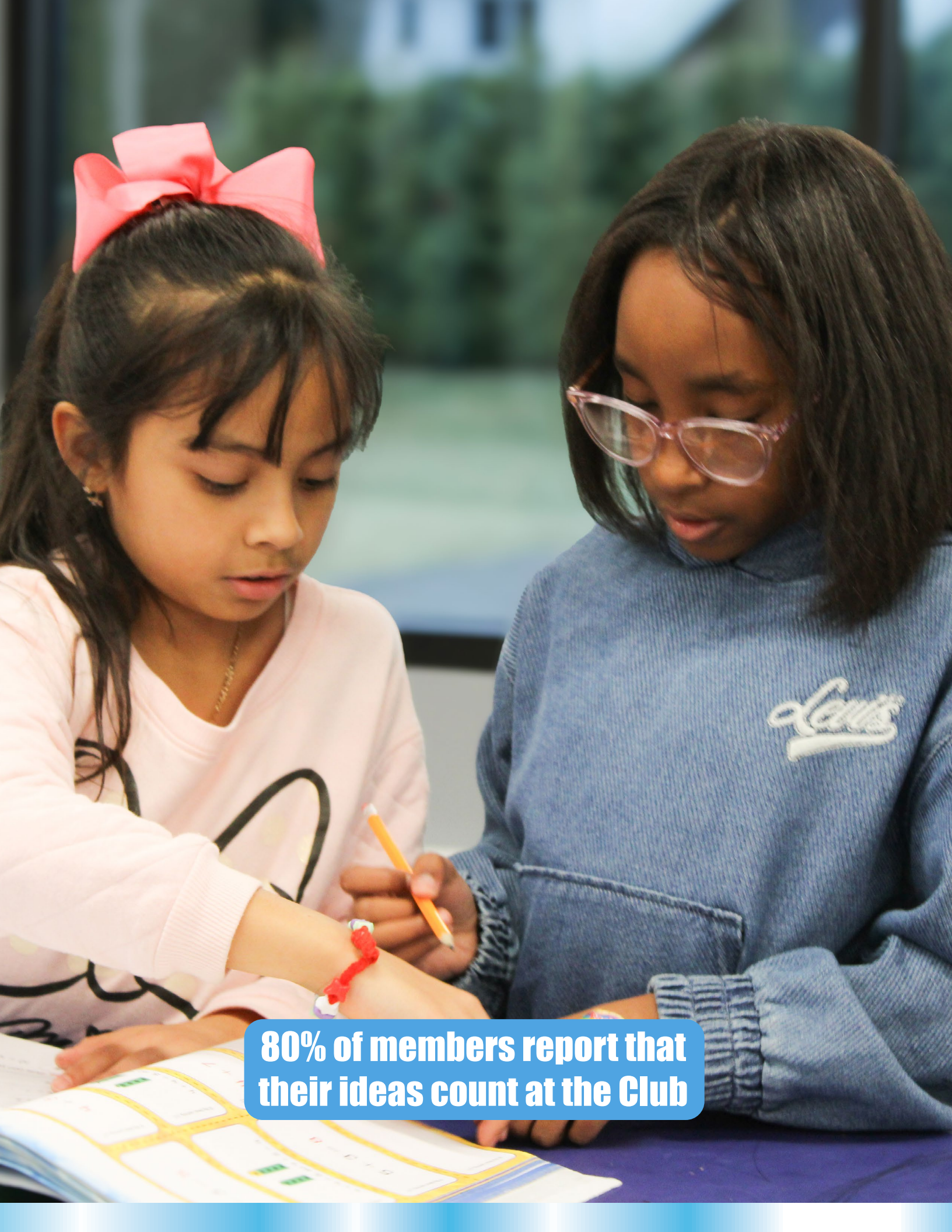

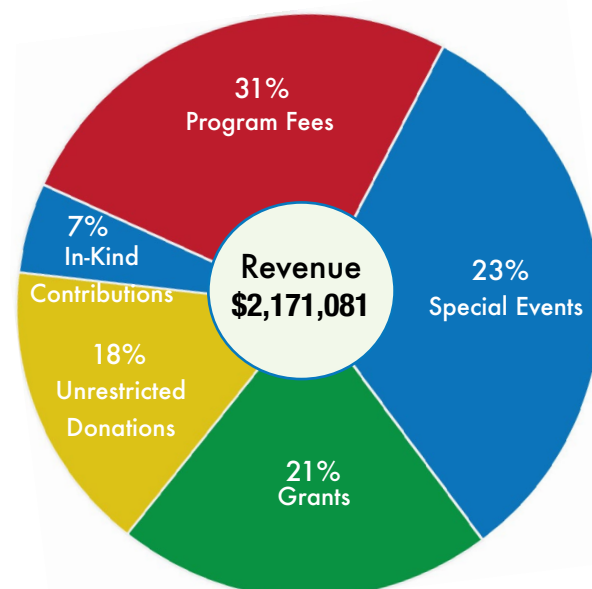

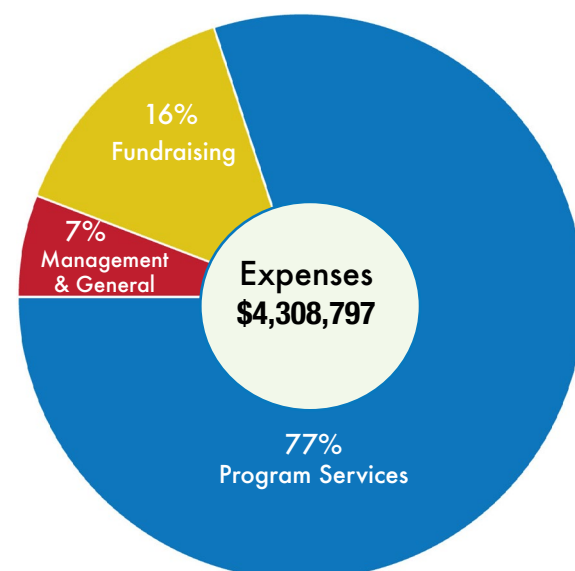

Total Operating Revenue

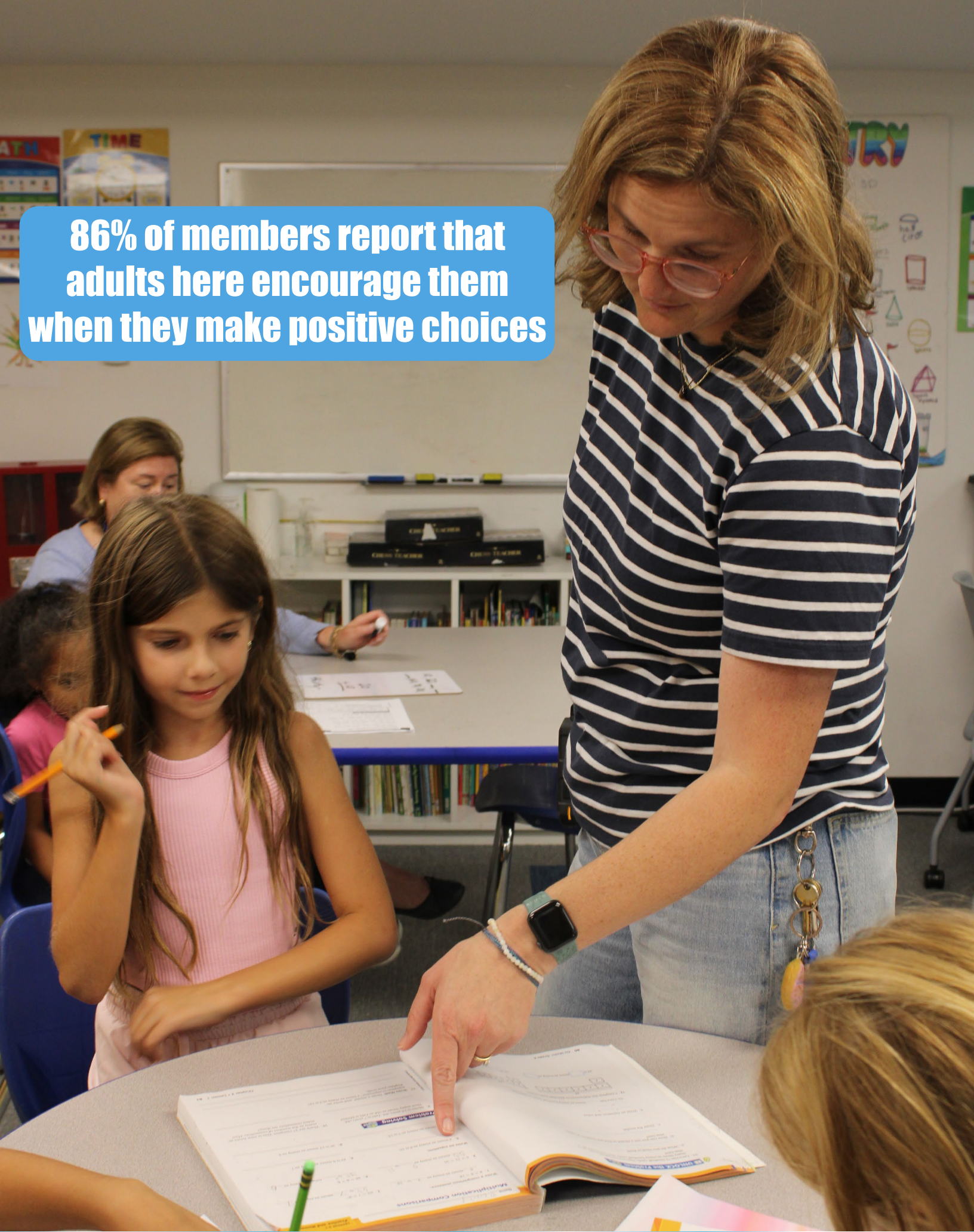


GBBGC derives its operating revenue from four main funding sources: Donations, Grants, Special Events and Program Fees.
